1 INTRODUCTION

This Regulation is issued as an annex of the “certification procedure” (PRC 01) document and is an integral part of it when approved by the representative Committee of the parties.

2 REGULATION

2.1 Use of the certificate and the mark

The use of the “VS Enama” or “Enamagroenergie” certificate and of the certification marks will be granted to the Client only after the successful completion of the accreditation procedure, which means after the issue of the certificate.

The “VS Enama” or “ENAMAgroenergie” Mark may be used on the price lists of companies selling certified products. However, should said price lists also list products which are not ENAMAgroenergie certified, the latter must be identified as such.

Companies must explain the significance and importance of the certification to their Clients as a recognition, on domestic and foreign markets, of the quality of certified products.

The certification mark and the certificate are Enama properties.

The regulation describes the situations in which Enama may suspend the certificate and the use of the mark.

2.2 Copy of the certificate and of the mark

The Client may reproduce the certificate and the mark only integrally, they can being enlarged or reduced in a uniform way, only if they are eligible and not altered concerning the form and the contents.

ENAMA monitors the property rights, use and exhibition of certificates and marks. Any improper reference to the certification system and any improper use of the mark or certificate in publicity, catalogues, etc. will result in suspension of the certification.

2.2.1 VS Enama

Following to the “VS Enama” certification, Enama will deliver the first 50 sticky labels containing the mark to put on machines/components, the certificate “VS Enama” in Italian and English language, the CD-rom containing the mark and the instructions for its use.

When the company signs the certification contract, it must act conform on the rules Enama certification.

The VS ENAMA mark must be affixed to each example of equipment constructed in accordance with certificate example.

The VS ENAMA mark must be requested to Enama and it must be used equal in number to the quantity of the machines produced in accordance with the certified model.

The VS ENAMA mark must be affixed on documentation of the relating certified machine, in conformity with standards illustrated graphically in Figure 2, and in particular including the number corresponding to the certificate.

The mark may be affixed only on documentation relating to the certified machine and may not appear on documents which include several models, also if only some of them are certified models, unless a specific reference is done to those certified.

The VS ENAMA mark may be used on the Client's publicity materials only if this material refers, entirely or in part, to VS ENAMA certified products, unless specific reference, as for the previous case, to those certified.

2.2.2 ENAMA*agroenergie*

ENAMA monitors the property rights, use and exhibition of **ENAMA*agroenergie*** certificates and marks. Any improper reference to the certification system and any improper use of the mark or certificate in publicity, catalogues, etc. will result in suspension of the certification.

Authorisation to use the ENAMA*agroenergie* Mark according to the criteria of this procedure is issued by ENAMA to companies which have obtained certification of their product/process.

The certified manufacturer / distributor possesses a specific certification mark for each quality class of solid biofuel he manufactures/distributes.

In stipulating the certification contract, the Client agrees to observe ENAMA's certification rules at all times.

The ENAMA*agroenergie* mark must be affixed to each product (package, tanker, etc.) conforming to the certificate.

Certified companies which produce or sell both certified and uncertified solid biofuels must adopt measures to prevent their entire product line appearing to be certified. Consequently the ENAMA*agroenergie* mark may be included only in documentation relating to the certified product/process, in conformity with the criteria illustrated graphically in Figure 1, in particular including the number corresponding to the certificate. The mark may be affixed only to documentation relating to the certified product/process and may not appear on documents which include other products than solid biofuels.

The ENAMA*agroenergie* mark may be used on the Client's publicity materials only if said material refers, entirely or in part, to certified solid biofuel products, adopting the same criteria as in the previous point.

The ENAMA*agroenergie* Mark may be used on the price lists of companies selling certified products. However, should said price lists also list products which are not ENAMA*agroenergie* certified, the latter must be identified as such.

Companies must explain the significance and importance of the ENAMA*agroenergie* certification to their Clients as a recognition, on domestic and foreign markets, of the quality of ENAMA*agroenergie* certified products.

For all aspects, reference is made to the contract stipulated between ENAMA and the Client (CO 01)

2.3 Concession and use of the certification mark

The Client has the right to use the mark in accordance to the requirements indicated in this regulation.

In case of the uncertainties, the Client must contact Enama for confirmation about the correctness of reproduction.

If the Mark is reproduced on the internet, these requirements are prescribed equally.

The Mark is realized in a format and it must be used together to Client's Mark and together to certified denomination of the machine/component.

It is not possible to use the Mark separately to the indication of the Client and to the certified product.

In case of suspension of the certification (CO 01) it is not allowed the use of the VS ENAMA and ENAMA*agroenergie* Marks.

2.4 Use of the logo bearing the ACCREDIA mark

Following the ENAMA accreditation as Certification Body from ACCREDIA, the Client will be able to also use the ACCREDIA Mark according to the ACCREDIA regulations on the use of the marks (RG-09 ACCREDIA).

2.5 Using the ENplus® mark.

As regards the use of the **ENplus® mark**, of the certificate and of the packaging graphics, refer to what expressly provided in the ENplus® Handbook, Part 2, chapters 2.1, 2.4, 2.5, 3.2 / 5, 4.2 / 5, 5.2 / 5, 3.3, 3.4, 3.5. and in the Guidelines "ENplus® G 1: 2018" and "ENplus® G 2: 2018".

2.6 Using the Biomass plus mark.

As regards the certification of other solid biofuels, ENAMA is the Certification Body authorised by AIEL to issue the **Biomass plus** voluntary mark; the ID number accompanying the mark is issued by AIEL (if requested by an Italian company), pursuant to the cited agreements. The Biomass plus mark (and ID number) are included in the ENAMA*agroenergie* certificate, and its use is regulated by AIEL according to the specific guidelines with which the Client declares he is familiar and accepts when stipulating the contract governing his relations with ENAMA (CO 01).
