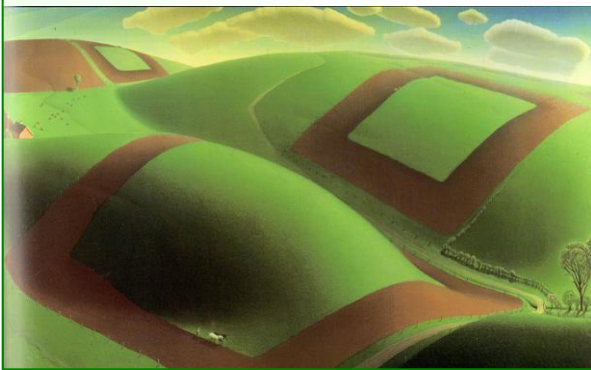


Training methodology

The training materials are based on a design coherent with EQF (European Qualifications Framework) , from Level 2 to Level 5, as a consequence of a survey on training needs for use, management and functional control in Italy, Spain and Turkey. Training content and didactic tools are linked to the agricultural sector with specific focus on human health, food safety and environment, aiming to share and exchange good practices on sprayer machinery and equipment.

Combined methodologies are foreseen (front classroom, online and offline learning, blended methodology) to assure and make easier the access to lifelong learning programmes for farmers and professionals devoted to become expert in safe use, management and control of sprayers.

The **IMPLEMENT training platform** is addressed to all farmers who are responsible for use and management of sprayers. Also machinery manufacturers, experts and persons in charge of functional controls are concerned. The course can be followed by choosing whatever modules and performing an online final test in reference to EQF levels from 2 up to 5. A final piloting test based on multiple choice questions will provide a certificate to the trainee.

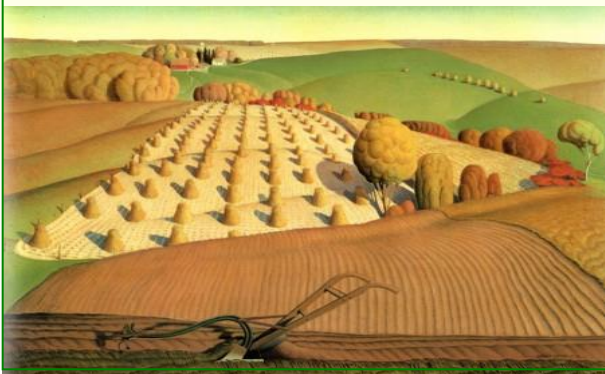

IMPLEMENT Project Target Groups

The IMPLEMENT project, "Integrated Management of Pesticides and Liabile Exposure with Machinery Executing Needed Treatments", granted under the Erasmus+ Programme Strategic Partnerships VET KA202, aims at disseminating good and innovative practices for European farmers on the use of pesticides and other plant protection chemicals, also in comparison with similar standards used in Turkey, with a specific attention to i) safety of operators, ii) environmental protection from diffusion of toxic and polluting products, and iii) food safety.

The project is coordinated by the Ondokuz Mayıs University, Turkey, and partners are: Agricoltura è Vita Associazione and ENAMA, Italy, ASAJA Granada, Spain and Ankara University and University of Çukurova, Turkey.

Main target users are: a) farmers and sprayers operators; b) agronomists, trainers and persons in charge of the prevention and protection service at work; c) technicians in charge for functional controls of sprayer machineries; d) manufacturers of sprayer machineries with specific reference to providing user friendly use and maintenance manuals.



IMPLEMENT Outputs

The IMPLEMENT project is a 24 month Erasmus+ Strategic Partnership VET project that aims to achieve as main outputs :
